

# Privacy Policy

This Privacy Policy ("Policy") applies to [www.stevensoncohomes.com](http://www.stevensoncohomes.com), and Stevenson & Co. Homes ("Company") and governs data collection and usage. ## Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

- First and last name
- Email address
- Phone number

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. ## Sharing Information with Third Parties

The Company does not sell, rent, or lease its customer lists to third parties.

- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest
- Enable solely internal uses that are reasonably aligned with your expectations based on your

- Otherwise use your personal information, internally, in a lawful manner that is compatible with
